Seminars are Back!

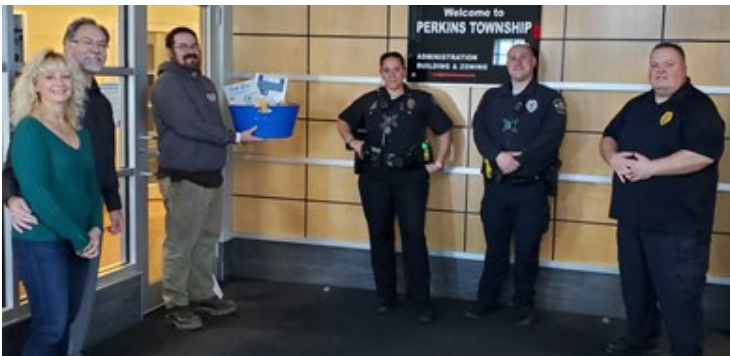


We have made the decision to offer our seminars live once again. We will also video them at the same time, so you can watch from home.
